ELEMENTARY AFTER SCHOOL PROGRAM REGISTRATION

The After School Programs in our ten elementary schools provide a safe, nurturing, enjoyable environment for students after the regular school day. The success of our After School Program can be attributed to the combined efforts of school administrators, program coordinators, the team of workers, and the families who entrust their children to us for this extended time each day.

After School Program REGISTRATION for the 2023-2024 school year will begin on Monday, April 3, 2023.

Registration will be open at each school's After School Program site on Monday-Friday from 3:30-5:30pm on the dates listed below for the categories of students listed for each:

- April 3: Students who are **currently enrolled in the ACS After School Program** will be eligible to register.
- April 17: Open registration for **new After School Program student participants** who will be in **grades 1-5**.
- April 28: Open registration for new After School Program student participants who will be in **Kindergarten**.

If you are interested in enrolling or would like more information about the extended day program at your child's school, please contact the After School Program Coordinator at the school your child will attend in 2023-2024. Additional information about the extended day services can also be found on each school's website.

The Auburn City Schools After School Program tuition rates for 2023-2024 are as follows:

Students returning to the After School Program (including students transferring to a different school)

After submitting all registration forms to the After School Program Coordinator where the child will attend school next year, parents should pay the annual, non-refundable registration fee of \$25.00 through My School Bucks. Students returning to the After School Program who will attend Woodland Pines Elementary School will pay their registration fee through My School Bucks by selecting WPES as the school. The deadline for payment of the registration fee for returning students is April 12.

Students new to the After School Program (including rising Kindergarten students)

New students to the After School Program should call the After School Program Director at the appropriate school before submitting forms to ensure spots are available. Please note that new participants will be accepted only until program capacity is reached; at such time a waiting list will be developed. New students to Woodland Pines Elementary will pay their registration fee at Dean Road Elementary School. The deadline for payment of the registration fee for rising first through fifth grades is April 21. The deadline for payment of the registration fee for rising Kindergarteners is May 5.

After School Program enrollment is not transferrable between schools. Students who transfer to another ACS school at any time and wish to enroll in the new school's After School Program should follow the program registration process of the new school.
